Dear Parents/Carers,

### **Return to School – Monday 8 March 2021**

I hope this letter finds you and your families safe and well. You will be aware that last Monday the Government published its long-awaited guidance and plans for all pupils to return to school from Monday 8 March. With this in mind, I want to share some information with you about how our school will operate when pupils return.

#### **Start Date**

All pupils in all year groups will return to school on Monday 8 March. Attendance is compulsory, and your child should only be absent from school if he/she has tested positive for Covid-19, is symptomatic, self-isolating or otherwise unwell.

#### **School Logistics**

The school will operate in the same way as it did during the Autumn term. Our priority is, and continues to be, the safety and wellbeing of our community and as such our system of controls remains in place, including staggered start and end times to the school day, contained class 'bubbles' and enhanced cleaning. This will be communicated fully with pupils on their return.
