DEED OF VARIATION

The parties to this Deed are:

(1) The Secretary of State for Education ("the Secretary of State"),

- and -

(2) Pontefract Academies Trust a charitable company incorporated in England and Wales with registered number 08445158 whose registered office is at C/O St Mary's Community Centre, The Circle, Pontefract, West Yorkshire, WF8 2AY ("the Academy Trust").

together referred to as the "Parties"

INTRODUCTION

- A. The Parties entered into a funding agreement dated 27 March 2013 ("the Supplemental Funding Agreement") relating to the establishment, maintenance and funding of an independent school known as The Rookeries Carleton Junior and Infant School.
- B. The Parties now wish to vary and amend the terms of the Supplemental Funding Agreement and wish to record their agreement as to such variations/amendments to the Supplemental Funding Agreement by this Deed.

LEGAL AGREEMENT

- 1. Any word or phrase used in this Deed shall, if that word or phrase is defined in the Supplemental Funding Agreement, bear the meaning given to it in the Supplemental Funding Agreement.
- 2. The Secretary of State and the Academy Trust agree that with effect from the date of this Deed the Supplemental Funding Agreement shall be amended in accordance with Schedule 1 to this Deed.
- 3. As varied by this Deed, the Supplemental Funding Agreement shall remain in full force and effect.
- 4. This Deed shall not effect the Master Funding Agreement made between the same parties dated 27 March 2013 which shall remain in full force and effect.
